# HOW to become a CSA Sanctioned Adult Tournament:

Tournament sanctioning is a member service provided to CSA Affiliate Members. A complete application includes:

- 1. One-page Sanctioned Adult Tournament Application
- 2. Tournament Competition Rules
- 3. Non-refundable Application Fee of \$100.00

## **BENEFITS of becoming a CSA Sanctioned Adult Tournament:**

- Promotion on CSA's website at www.coloradosoccer.org
- Eligibility to apply through CSA to USSF for permission to host foreign teams
- Tournament and players covered by insurance, including General Liability and Secondary Soccer Accident Insurance. CSA/USASA insurance coverage cannot be used for non-CSA sanctioned tournaments.

# **RESPONSIBILITIES of being a CSA Sanctioned Adult Tournament:**

- To comply with the rules and regulations of CSA, USASA, USSF and FIFA
- To use active CSA certified and trained USSF Referees and Assignors
- To ensure that all accepted players are registered (both online and on-site registration resources will be provided to you by CSA)
- To report violent conduct or assaults to CSA within 72 hours
- Submit team fees of \$150.00 per Adult team accepted within ten (10) days of Tournament conclusion. Payment to be submitted to CSA 4643 S. Ulster Street, Ste 250., Denver CO 80237









# SANCTIONED ADULT TOURNAMENTS RULES AND REGULATIONS

- I. Sanctioned Adult Tournaments must be hosted by a CSA Affiliate Member organization.
- II. Applications for Sanctioned Adult Tournaments must be submitted to the CSA Office, and approvals will be made by the CSA.
- III. A complete application includes:
  - a. One-page Sanctioned Adult Tournament Application
  - b. Tournament Competition Rules
  - c. Nonrefundable Application Fee of \$100.00
- IV. Tournaments may apply for approval to invite foreign teams through USSF. This application must be submitted to CSA, and includes:
  - a. U.S. Soccer Application to Host a Tournament or Games Involving Foreign Teams (HAPP 3-03)
  - b. U.S. Soccer International Tournament/Games Hosting Agreement (HTED 3-03)
  - c. Tournament Rules
  - d. \$75 check payable to U.S. Soccer
- V. Amendments to the original tournament application must be forwarded to CSA.
- VI. CSA Sanctioned Adult Tournaments may not be concurrently sanctioned by any other organization.
- VII. Teams and players from outside Colorado may present player passes from their state association and/or USASA affiliate organization.
- VIII. All tournament participants must be registered with a USASA affiliate.
  \$150.00 per team registered will be payable to CSA and must be received within ten (10) days of the completion of the event.
- IX. CSA Sanctioned Tournaments which host concurrent youth and adult competitions are responsible for facilitating a fun and safe environment for all involved. Considerations may include providing safe distance between youth and adult fields to avoid injuries, precautions when alcohol is present, appropriate supervision, etc.
